## Security and Fraud Controls

- Driver ID is required before transaction can be completed
- Set prompts to ask driver ID, or driver ID and odometer reading
- Deactivate lost/stolen cards or order new cards immediately
- Only fleet managers can access driver information

## Individual Settings and Less Paperwork

- Set limits for each card by day or month
- Eliminate hassle of collecting receipts and reimbursement

## Enhanced Reporting

- Driver Report, Vehicle Report, Exceptions Report and more

## Save on BP Fuel

- Earn rebates on gasoline and diesel purchases
- Monthly gallons for gasoline and diesel are totaled separately and rebate is based on the chart shown
- Diesel rebates reach a maximum of 3.5¢\* per gallon

### Example:

Total of 6,000 gallons of fuel (gasoline and diesel) purchased for the month  
**4,000 gasoline** = 4.0¢ per gallon rebate (\$160)\*  
**2,000 diesel** = 3.5¢ per gallon rebate (\$70)\*  
**\$230 rebate earned\***

### Monthly rebates are on cents per gallon of fuel as follows:

gallons	rebate (per gal)
0 – 299	0
300 – 2,999	3.5¢ <sup>†</sup>
3,000 – 7,999	4.0¢
8,000 – 9,999	5.0¢
10,000+	6.0¢

<sup>†</sup>Maximum rebate for diesel.

## Membership Fee

- \$10 monthly membership fee for accounts purchasing less than 5,000 gallons per month (fee waived if purchases exceed 5,000 gallons)

per gallon in rebates  
for the 1st three months.

\*Limited time offer valid for new BP Business Solutions Plus Card applications received from 8/3/2015 through 10/4/2015. New approved accounts will earn 20 cents per gallon rebate on BP fuel purchases in the first three (3) months after account opening in addition to the ongoing tiered rebate. The maximum rebate earnings are on 2,000 gallons per month regardless of billing terms. Purchases must be made with your BP Business Solutions Plus Card and the account must be in good standing. Rebates will be reflected on your billing statement in the form of a statement credit. Rebates are cents per gallon based on the number of gallons purchased at BP locations per billing cycle. Rebates are subject to change at any time without notice. Rebates may not be allowed where prohibited by law and apply only to fuel purchases made at participating BP branded locations in the U.S. Only "road" (low sulfur) diesel is eligible for a rebate. Not valid on aviation, bulk fuel, propane or natural gas purchases.
